SECURITY DEPOSIT

Renter will be required to make a non-refundable security deposit in the amount of \$_____ dollars ("Security Deposit") to be used in the event of loss or damage to the rental trailer during the term of this agreement. Rental trailer owner may, in lieu of collection of a security deposit, place a hold on a credit card in the same amount. In the event of damage to the rental trailer, Owner will apply this Security Deposit to defray the costs of necessary repairs or replacement. If the cost for repair or replacement of damage to the rental trailer exceeds the amount of the Security Deposit, Renter will be responsible for payment to the Owner of the balance of this cost. If no damage occurs then the Security Deposit will be applied to the Renters overall fee balance.

INSURANCE

Renter must provide Owner with proof of insurance that would cover damage to the rental trailer at the time the agreement is signed as well as personal injury to the Renter, Secondary Renter(s), and other persons or property within 100 feet of the rental trailer. This is a potentially very dangerous piece of equipment and is only to be used by the Renter or Secondary Renter(s). If the rental trailer is damaged or destroyed while it's in the possession of the Renter or Secondary Renter(s), Renter agrees to pay any required insurance deductible and also assign the rights to collect insurance proceeds to Owner. If you are a business, a \$1,000,000 minimum policy is required.

INDEMNIFICATION

Renter agrees to indemnify, defend and hold harmless the Owner for any loss, damage or legal actions against Owner as a result of Renter's operation or use of the rented trailer during the term of this trailer rental agreement. This includes any attorney fees necessarily incurred for these purposes. Renter will also pay for any parking tickets, moving violations or other citations received while in possession of the rental trailer.

REPRESENTATIONS AND WARRANTIES

Owner represents and warrants to that the Owner's knowledge, the rental trailer is in good condition and is safe for ordinary operation of this rental trailer.

Renter represents and warrants that renter is legally entitled to operate the rental trailer under the laws of this jurisdiction and will not operate it in violation of any laws, or in any negligent or illegal manner.

Renter has been given the opportunity to examine the rental trailer in advance of taking possession of it, and upon such inspection, is not of any damage existing on the rental trailer other than that noted by a separate Existing Damages Document

In the event of any dispute over this agreement, this Trailer Rental Agreement will be interpreted by the laws of Riverside County, California, and any lawsuit or arbitration must be brought in the corresponding region of Riverside County, California. If any portion of this agreement is found to be unenforceable by a court of competent jurisdiction, the remainder of the agreement would still have full force and effect.

ENTIRE AGREEMENT

This Trailer Rental Agreement constitutes the entire agreement between the Parties with respect to this rental arrangement. No modification to this agreement can be made unless in writing signed by both Parties. Any notice required to be given to the other party will be made to the contact information below.

ADDITIONAL REQUIREMENTS
